



Tesla battery tax credit

Can you get a tax credit on a Tesla?

Customers who take delivery of a qualified new Tesla vehicle and meet all federal requirements are eligible for a tax credit up to \$7,500, which can be deducted from the purchase price at time of delivery for eligible cash or financing purchases through Tesla. Customers are limited to two time-of-sale tax credits per year.

What tax credits are available for electric vehicles?

Tax credits up to \$7,500 are available for eligible new electric vehicles and up to \$4,000 for eligible used electric vehicles. You can work with your dealership to process the vehicle tax credit. Tax credits are available for home chargers and associated energy storage, each up to \$1,000. Make sure you meet the requirements below.

Can Tesla tax credits be applied to leased vehicles?

A: Yes, Tesla tax credits can sometimes be applied to leased vehicles, depending on the structure of the lease agreement. In many cases, the leasing company, as the vehicle's owner, claims the tax credit and passes the savings on to the lessee in the form of lower monthly payments.

Does Tesla offer tax incentives?

Tesla does not guarantee vehicle delivery or energy system installation or permission to operate by a specific date or incentive deadline. Your eligibility for any tax credits depends on your personal tax situation. We recommend speaking with a tax professional for guidance. Federal tax incentive amounts and requirements may continue to change.

How much is a Tesla tax credit in 2025?

The federal Tesla tax credit for qualifying new Tesla purchases is \$7,500 with a max MSRP of \$55,000 - \$80,000. However, the evolving nature of government policies means opportunities for incentives are always changing. In 2025, the Federal incentive will be easier to pocket! It is no longer just a tax credit.

How do I file a Tesla EV tax credit?

How Do I File? Your Clean Vehicle Report is available in your Tesla Account, which is a necessary document to claim your EV tax credit on Form 8936. You will need to report the credit on your tax return whether you applied the credit to reduce your final vehicle payment or not.
